

Clara Hughes Public School Boundary Review Consultation October 18, 2022



Land Acknowledgement

The Durham District School Board acknowledges that many Indigenous Nations have longstanding relationships, both historic and modern, with the territories upon which our school board and schools are located. Today, this area is home to many Indigenous peoples from across Turtle Island. We acknowledge that the Durham Region forms a part of the traditional and treaty territory of the Mississaugas of Scugog Island First Nation, the Mississauga Peoples and the treaty territory of the Chippewas of Georgina Island First Nation. It is on these ancestral and treaty lands that we teach, live and learn.

This statement was co-created in partnership with the Mississaugas of Scugog Island First Nation and the Chippewas of Georgina Island.



Overview

- An information report on the proposed boundary review for Clara Hughes Public School was presented to Trustees at the October 17, 2022, Board Meeting.
- The purpose of the report was to initiate this consultation process to gather community input on the proposed boundary change option intended to alleviate the enrolment pressures at Clara Hughes Public School.
- The Board Report, PowerPoint presentation, School Newsletter and a survey were posted to the Board website and are accessible through the affected schools' websites (Clara Hughes Public School and Village Union Public School).



Overview, Continued

- The option under consideration is provided on the following slides for community input.
- A Virtual Public Meeting will be held to solicit public input on November 24, 2022, at 7:00 p.m. Notice of this meeting will be provided on the Board's and affected schools' websites.

- All input will be summarized in the February 2023, Recommendation Report to Trustees.
 - Trustees will make a decision at the February 2023 Board Meeting.



Boundary Review

- Clara Hughes Public School (CHPS) is experiencing enrolment pressures within the existing enrolment boundary of the school:
 - CHPS is located in a mature neighborhood on 5.68 acres of land.
 - Families with young children are moving into the area attracted by affordable housing prices and a newer school with Child Care.
- As of September 2022, the school is operating at 184% utilization. For the 2023-24 school year, it is projected to operate at 193% utilization if all students are attending in school learning.
 - Utilization compares the enrolment at the school to the Ministry of Education's Rated Capacity (MRC) of the school.
 - Enrolment pressure is projected to increase over time (see slide 8).



Boundary Review Continued 2

- The CHPS building was opened in 2014 to accommodate 490 students. Preliminary September 2022 enrolments are in excess of 900 students.
- There is concern regarding the number of portables on site to accommodate the student body:
 - 15 portables on site currently and this number is projected to increase over time;
 - The site can hold a maximum of 18 portables
 - An increase in the number of portables results in a decrease in available play area for students.



Boundary Review Continued 3

- Program scheduling in specialized spaces (i.e., Gym) is a concern when trying to meet the needs of all students.
- The school has two recess periods in the morning and two in the afternoon in order to ensure student safety given the large student body.
- Overcrowding at CHPS has resulted in traffic congestion as students are dropped off and picked up.




Proposed Option For Consultation

- For the 2023-24 school year, all JK to Grade 7 students residing north of Olive Avenue and west of Central Park Blvd. South would attend Village Union Public School (VUPS) instead of CHPS.
- Should the above option be approved by the Board of Trustees, students entering Grade 8 in 2023-24 will have the option of staying at CHPS and graduating with their peers or attending VUPS for their graduating year.




Clara Hughes PS and Village Union PS – **ODSE** Existing Enrolment Boundaries

Proposed Option Considerations for CHPS

- Between 2023-24 and 2026-27, an average of 318 students from the existing CHPS enrolment boundary would form part of the proposed realigned VUPS enrolment boundary.
- The CHPS enrolment pressure currently projected at 913 students for the 2022-23 school year would decrease to a projected 679 students in 2023-24. By 2026-27, this would further decrease to a projected 631 students
 - This would result in a reduction of portables at CHPS from the current 15 to 6 by the 2026-27 school year.
 - Pressure in scheduling programs in specialized spaces (i.e., Gym) is anticipated to decrease.
 - Traffic congestion as students are dropped off and picked up is anticipated to decrease.

Proposed Option Considerations for VUPS

- Between 2023-24 and 2026-27, VUPS enrolment would increase by an average of 318 students if the VUPS enrolment boundary was realigned as proposed.
- VUPS is located in the former Oshawa Central CI on 16.04 acres of land. The building was renovated to accommodate 549 elementary students; however, its 2022-23 enrolment is projected to be 385 students. As a result, the elementary space is underutilized (enrolment compared to MRC).
- The available existing space would be increased by the creation of approximately 9 classrooms to accommodate the total enrolment resulting from the proposed expanded VUPS enrolment boundary.
 - There would be sufficient space for future growth

Transportation And Staffing

- Durham Student Transportation Services (DSTS) identify safe walking routes for all schools.
- Under the DSTS Transportation Policy, students residing more than 1.6 km from their designated school of attendance would be eligible for school bus transportation.
- The number of school buses that may be required for the realigned CHPS and expanded VUPS enrolment boundaries will be determined by DSTS, should the boundary realignment be approved.



Transportation And Staffing Continued

- Crossing guards are a mandate of the City of Oshawa, and Durham Student Transportation Services would work with the City regarding the designation of crossing guards to accommodate safe travel for all students to their designated schools.
- Should the Board of Trustees approve this proposed Boundary realignment in February 2023 for implementation in September 2023, there will be sufficient time for decisions, that impact staffing of the two schools, to be made.
