- Input from tonight's Public Meeting will be included in the Final Recommendation Report to the Board of Trustees.

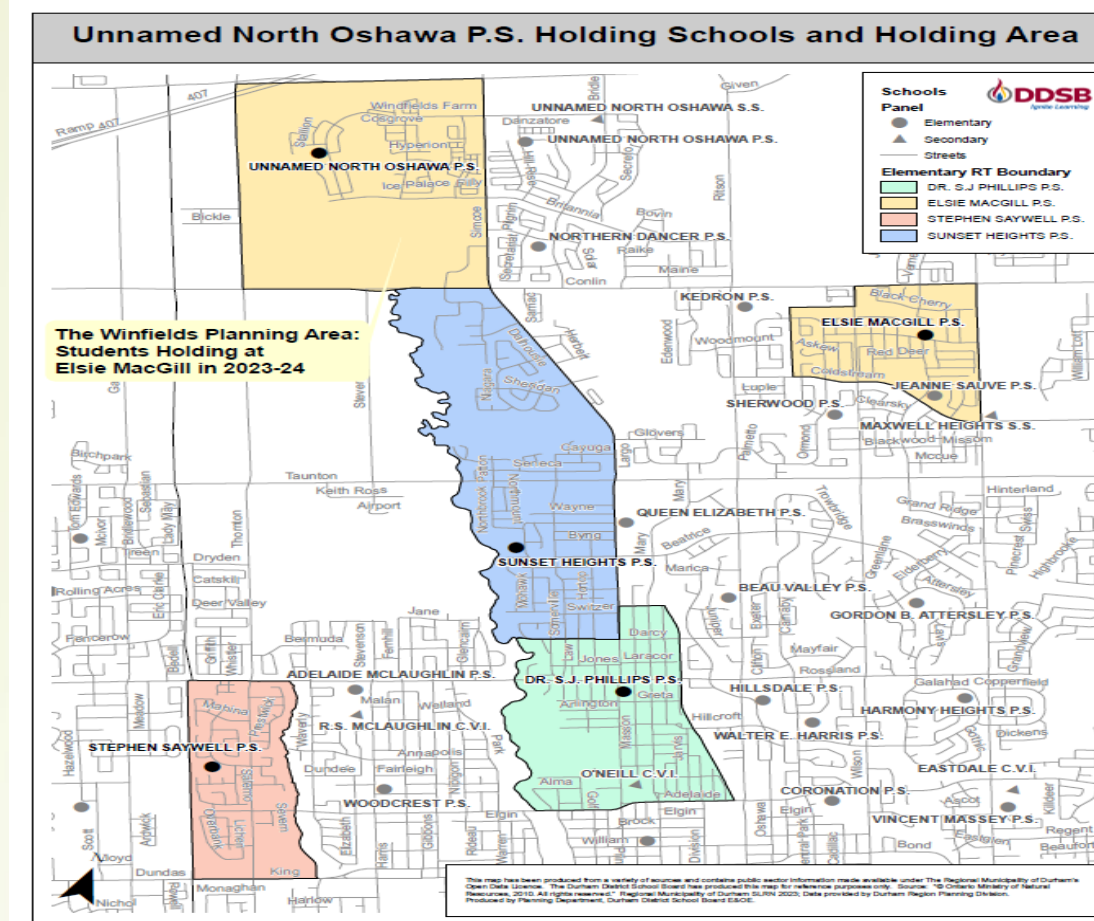
Overview, Continued

Boundary Review

- Unnamed N. Oshawa Public School (NOPS) received Ministry of Education Capital Priorities funding in October 2020. The school is currently under construction and scheduled to open for the 2024-2025 school year.
- Unnamed NOPS has a Ministry Rated Capacity (MRC) of 536 pupil places and will accommodate students from Junior Kindergarten to Grade 8, and includes a Child Care Centre.
- The neighbourhood is part of a greenfield development that attracts new families, including more affordable rental units.
- Four holding schools; Stephen Saywell PS, Sunset Heights PS, Dr. SJ Phillips PS and Elsie MacGill PS have been accommodating the growth from the area until the school opens for the 2024-2025 school year.

Unnamed N. Oshawa PS Holding Schools and Holding Area



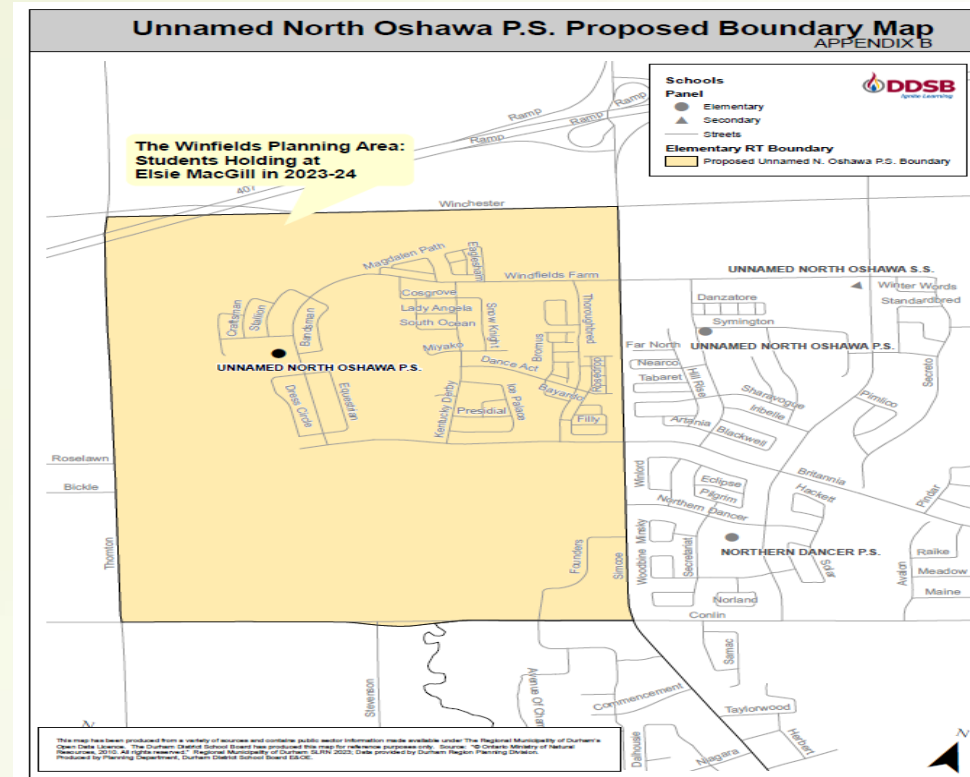
Holding Schools

- Holding schools are determined based on factors including the following:
 - Space to accommodate students (in school, portables and site size)
 - Transportation (distance to school and space to accommodate buses)
 - Adequate parking and washrooms.
- Students and their siblings attend their designated holding school (as long as they remain at their current address) until such time as the new school is open with a boundary in place.
- Details of the four holding schools are as follows:
 - Stephen Saywell PS was identified as the first holding school during the 2015-2016 school year until June 2018.
 - Sunset Heights PS was the second holding school and accommodated new students from the NOPS area until June 2021.
 - Dr. SJ Phillips PS was identified as the third holding school until June 2023.
 - Elsie MacGill PS is the current holding school.

Proposed Unnamed N. Oshawa PS Boundary For Consultation

- Unnamed N. Oshawa's proposed boundary encompasses the west side of Simcoe Street North, the north side of Conlin Road, the south side of Winchester Road West and the east side of Thornton Road.
- The proposed boundary aligns with the current holding school boundary in place since the development in the area began.
- For the 2024-2025 school year, the proposal includes JK to Grade 7 students residing within the proposed boundary. Current Grade 7 students would be given the choice to remain at their designated holding school or transition to the Unnamed N. Oshawa PS for Grade 8.

Unnamed N. Oshawa PS Enrolment Projections

- Below are Unnamed N. Oshawa PS enrolment projections upon opening, based upon current holding and growth.
- Based upon previous new DDSB school openings, a new facility attracts students from other sources, including publicly funded boards, private schools and DDSB families attending elsewhere. 50 new students are included per year in Unnamed N. Oshawa PS enrolment projections.

Impact on Holding Schools With Unnamed N. Oshawa PS Overview

- The opening of Unnamed N. Oshawa PS for the 2024-2025 school year will result in enrolment relief and the need for minimal portables to the four holding schools (Stephen Saywell PS, Sunset Heights PS, Dr. SJ Phillips PS and Elise MacGill PS).
- For the current school year, the four holding schools have a combined 23 portables on site.
- With the opening of Unnamed N. Oshawa PS, it is projected that there is a potential to redirect 18 portables to address other accommodation pressures and ensure there are fewer students in alternative learning spaces.
- The four holding schools will be provided some relief however they may be required in future years to accommodate the current and planned growth in Oshawa.
- In north Oshawa there are over 8,000 new homes proposed in the Kedron Planning Area and 8,700 new homes proposed in the Columbus Planning Area. The Kedron Planning Area development is already underway, while it is anticipated that the expansion of Columbus is 10 to 15 years away.

Considerations



- DDSB recognizes that good mental health is an important foundation for achievement and well-being.
- Schools are an ideal place for mental health promotion, the prevention of mental health concerns, and the early identification of mental health concerns through school-based prevention and intervention services. Schools provide students with the knowledge and skills to be aware of, care for, and advocate for their own mental health and well-being.
- Changes because of the proposed boundary shifts will be a transition for students and families. With this on mind, the mental health and well-being of students and their caregivers who may be affected by these changes are among the district's leading considerations.
- DDSB will be intentional in the transition supports for all students impacted by the change. Relationship building and facilitating a sense of school community, connectedness and belonging across all learning spaces will be key commitments throughout this process.

Considerations 2



- Durham Student Transportation Services (DSTS) identify safe walking routes for all schools.
- Under the DSTS Transportation Policy, students residing more than 1.6 km from their designated school of attendance would be eligible for school bus transportation.
- Should the Board of Trustees approve this proposed Boundary realignment in February 2024 for implementation in September 2024:
- DSTS will identify bus routes as applicable;
- There will be sufficient time for decisions to be made regarding the impact of staffing for Unnamed N. Oshawa PS and the four holding schools, to be made.

Input Received to Date



Comment:

- My children would like to continue at their current holding school rather than attend Unnamed North Oshawa PS when it opens for the 2024-2025 school year. They are not currently in Grade 7. Will transportation be offered so they can continue to attend their holding school?

Response:

- Transportation will be provided to students currently in Grade 7, if they decide to graduate with their peers at their current holding school.
- All other students will be transferred to their new school for the 2024-2025 school year. The DDSB's Out of Area Policy would apply to any students choosing to remain at their current holding school. In these cases, transportation would not be provided by DDSB.

Unnamed North Oshawa PS



- Unnamed NOPS school site is 7.7 acres in size.
- Unnamed NOPS has a Ministry Rated Capacity (MRC) of 536 pupil places and will accommodate students from Junior Kindergarten to Grade 8, with 4 kindergarten classrooms.
- The school includes a Child Care Centre.
- The Child Care provider for Unnamed NOPS is Kids' Campus. If you would like further information on Child Care for the school please contact Kids' Campus at 905-725-0123.

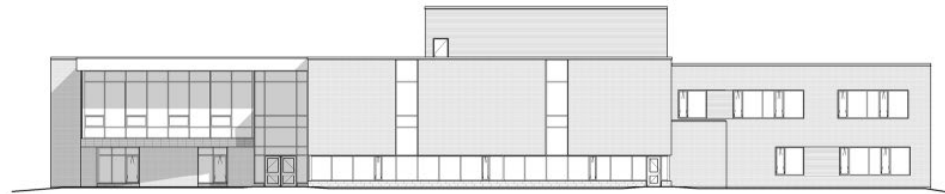

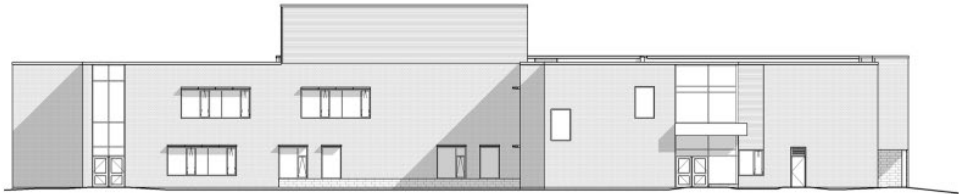
