Overview

- An information report on the review of the proposed boundary for Unnamed North Oshawa PS was presented to Trustees at the October 21, 2025, Board Meeting.
- The purpose of the report was to initiate this consultation process to gather community input on the proposed boundary for Unnamed North Oshawa PS, located at Symington Avenue and Steeplechase Street. The school is scheduled to open for the 2026-2027 school year.
- An In-person Public Meeting was held to solicit public input on November 10, 2025, at 7pm.
 There were 10 attendees.
- Notices of tonight's virtual Public Meeting were provided on DDSB's and partner schools' websites.

Boundary Review

- Unnamed North Oshawa Public School (NOPS) received Ministry of Education Capital
 Priorities funding in 2024. The school is currently under construction and scheduled to open
 for the 2026-2027 school year.
- Unnamed NOPS has a Ministry Rated Capacity (MRC) of 634 pupil places and will accommodate students from Junior Kindergarten to Grade 8.
- The neighbourhood is part of a greenfield development that attracts new families.




Partner Schools


- Three partner schools, Dr. S J Phillips PS, Kedron PS, and Sunset Heights PS, have been accommodating the growth from the area until the school opens for the 2026-2027 school year.
- While Northern Dancer PS is not considered a partner school, one of the established growth boundaries was originally part of this school's permanent boundary. As such, there are students residing within the proposed attendance boundary for Unnamed North Oshawa PS currently attending Northern Dancer PS.
- Partner schools are determined based on factors including the following:
 - Space to accommodate students (in school, portables and site size)
 - Transportation (distance to school and space to accommodate buses)
 - Adequate parking and washrooms.
- Students and their siblings attend their designated partner school (as long as they
 remain at their current address) until such time as the new school is opened with a
 boundary in place.

The original published proposed boundary map (left) was published and distributed to families at the partner schools. It was later found that the original published map did not reflect the correct area being considered as the proposed boundary for NOPS, and a corrected proposed boundary map (right) was released.

The current consultation area map includes the area East of Avalon Street, South of Pindar Crescent, West of Ritson Road N, and North of Conlin Road E.

The corrected map excludes the area East of Wilson Road N, South of Winchester Road E, West of Townline Road N, and North of Britannia Avenue E.

Transported vs Non-transported Area

Unnamed North Oshawa PS Growth Boundary

The new school will provide pupil accommodation for students residing in the area north of Conlin Road East at Thornton Road North to Winchester Road East; north of Britannia Avenue East at Simcoe Road North, south of Howden Road East, west of Townline Road North, and east of Thornton Road N.

The road network highlighted in red reflects the non-transported zone or the area within walking distance of the new school. Students residing outside of this area would be eligible for busing. As more development is constructed and new roads are developed, the transported vs non-transported area may be revised by the Durham Student Transportation Services (DSTS).

Proposed Unnamed North Oshawa PS Boundary For Consultation

- The proposed boundary aligns with the growth boundary currently in place since development in the area began.
- For the 2026-2027 school year, the proposal includes JK to Grade 7 students residing within the proposed boundary.
- Students in Grade 7 in the 2025-2026 school year would be given the choice to remain at the school they are currently attending with transportation provided or transition to the Unnamed North Oshawa PS for Grade 8.
- Younger siblings would attend the new school when it opens in 2026-2027. If families choose for younger siblings to remain at the current partner school, these students would be considered as out of area and transportation would not be provided. As such, DDSB's Permission to Enrol Procedure that describes the out of area process would apply families would require agreement from the principal and the school Superintendent.

Unnamed North Oshawa PS Enrolment Projections

- Based upon previous new DDSB school openings, a new facility attracts students from areas such as other publicly funded schools, private schools and DDSB families within the proposed boundary that decided to remain at their previous home school. Unnamed NOPS will continue to attract new students as development in the neighbourhood picks up.
- With the opening of Unnamed North Oshawa PS for the 2026-2027 school year, two of the four schools involved in this consultation are projected to require portables to accommodate growth.

Impact on Partner Schools With North Oshawa PS - Overview

- The opening of the Unnamed North Oshawa PS for the 2026-2027 school year will result in enrolment relief and the need for minimal portables to the three partner schools (Dr. S J Phillips PS, Kedron PS, Sunset Heights PS) and Northern Dancer PS.
- For the current school year, the three partner schools as well as Northern Dancer PS have a combined 31 portables on site.
- With the opening of the Unnamed North Oshawa PS, there is a potential to redirect 25 portables to address other accommodation pressures and ensure there are fewer students in alternative learning spaces.
- The three partner schools as well as Northern Dancer PS will be provided some relief;
 however, they may be required in future years to accommodate planned growth in the area.



Considerations

- DDSB recognizes that good mental health is an important foundation for achievement and well-being.
- Schools are an ideal place for mental health promotion and the early identification of mental health concerns through school-based prevention and intervention services. Schools provide students with the knowledge and skills to be aware of, care for, and advocate for their own mental health and well-being.
- Changes because of the proposed boundary shifts will be a transition for students and families. With this on mind, the mental health and well-being of students and their caregivers who may be affected by these changes are among the district's leading considerations.
- DDSB will be intentional in the transition supports for all students impacted by the change.
 Relationship building and facilitating a sense of school community, connectedness and belonging across all learning spaces will be key commitments throughout this process.

Considerations - 2

- Durham Student Transportation Services (DSTS) identify safe walking routes for all schools.
 This is known as the Non-transported Zone.
- Under the DSTS Transportation Policy, students residing more than 1.6 km from their designated school of attendance would be eligible for school bus transportation.
- Should the Board of Trustees approve this proposed new Boundary in February 2026 for implementation in September 2026:
 - DSTS will identify bus routes;
 - There will be sufficient time for decisions to be made regarding the impact of staffing for Unnamed North Oshawa PS and the three partner schools.

- DDSB's Early Years department is examining need and options for the provision of a Before- and After-school child care at the Unnamed North Oshawa PS.

Kindergarten Registration

- Kindergarten Registration for the 2026/2027 school year will open on Tuesday, January 6th, 2026.
- To register for Kindergarten, your child must:
 - be 4 years old by December 31 in the current year (Junior Kindergarten)
 - be 5 years old by December 31 in the current year (Senior Kindergarten)
- Families are encouraged to submit their registration early. Benefits for early registration include:
 - Earlier access to information and resources
 - Connection to the school community (i.e., invitation to school events)
 - Opportunities to meet with school teams (i.e., Kindergarten Team)

Comment:

I have a daughter who is currently in grade 7 at Kedron. She has attended Kedron since junior kindergarten. Next year when she is in grade 8, will she be able to stay at Kedron?

Response:

Yes, your daughter would be able to stay at Kedron PS for her Grade 8 year. Students who reside in the growth boundary and are entering Grade 8 in September 2026 (current Grade 7 students) will have the choice to remain at their existing designated partner school.



Comment:

My son started JK this year at Sunset Heights. We live in North Oshawa. The new unnamed public school is right by our house.

My question is.. will my son be required to change schools in September 2026, as the new school would now be considered his home school?

Response:

- Current students from JK to grade 6 will be transferred to the new school for the 2026-2027 school year. The DDSB's Out of Area Policy would apply to any students choosing to remain at their current partner school. In these cases, transportation would not be provided by DDSB.
- Transportation will be provided to students currently in Grade 7, if they choose to graduate with their peers at their current partner school.

Comment:

What will the unnamed school hours be? And will there be accessible daycare for before/after-school?

Response:

- A decision on bell times would be made after a permanent boundary for the Unnamed North Oshawa PS is approved by the Board of Trustees at the February 18, 2026 Board Meeting.
- DDSB's Early Years department is examining need and options for a Before- and After-school child care program at the Unnamed North Oshawa PS. Comment:

The entire "Kedron" community (Avalon to Ritson, South of Britannia to Conlin) has now been included inside the boundary. These homes have been attending Kedron PS for over 40 years!

This has a tremendously negative impact on my family personally. We are members of the YMCA before and after care program at Kedron, we walk to and from school almost everyday (as do a LOT of families in our particular neighborhood), and we a specific IEP program in place with school administrators and daycare staff to provide unique supports for one of our daughters.

Please provide details if this change was inadvertent or how we show can support to revert to the original mapping?

Response:

 DDSB staff will provide an impact analysis of your option and include it in the Final Recommendation Report for the Trustees.
